The city wants to create franchise agreements with utility companies stating that have the right to operate in the right of way.

Director Jessica Bain motions to have Hole in One Construction LLC fix siding on Model's pump house on Pines Road. Director Goff seconds the motion. Director Bain also proposes to approve the proposed expenditure budget of 2024 and Director Goff second. Motion passes. A motion was made to pay the expenditures for October, and this motion also passes.

C. Gene St. Godard, hydrogeologist, specializing in water rights addresses the board. He discusses two stages to begin work. He will need to decide if the proposed site is viable, and if so, start the building of a production well. Gene wants to obtain approval from ecology, today, if possible. He recommends using the Conservancy Board for the change to the point of withdrawal as it might be quicker than using the Department of Ecology. Jesse Cowger stresses that decision is up to Model. Gene would like to install a pitot meter to sample tap depth of water, permeability, soil samples, and thickness of the aquifer. He intends on contacting Fairmount to do a feasibility study from their existing well.

He will be able to check on general characteristics. Some water testing will also be done on the water from Fairmont's existing well, after flushing.

- D. Jesse Cowger explains the status of Model's current water rights and certificates. Ten certificates make up Model's entire portfolio, which all can be withdrawn.
- E. Aaron discussed options for time frames for completion of the well, reservation of ERU's. There is discussion about whether or not the Board is agreeable with the terms that have been set forth by the Developer.
- F. Todd Whipple requests that the Board reach an agreement or at least authorize Superintendent Rick Neal to sign a certificate of water availability.
- G. Ryan Heaton calls for an executive session at 3:45 pm for 15 minutes. Prior to convening in an executive session, Ryan Heaton publicly announced the purpose for excluding the public from the meeting place, and the time when the executive session would be concluded. The purpose was to discuss potential legal risks and financial consequences of accepting the Developer's proposal to donate the well.
- H. Meeting was resumed at 4:00pm and at the request of the Board, Aaron shares with everyone the Board's decision that it would acknowledge that it will accept donation of a well if the conditions proposed by the Developer are met. Aaron explains that the Board may want to revise some of the preliminary statement contained in the Developer's proposal to clarify that it is the Developer's proposal to donate a well. Under the proposal, Model would authorize Rick how many ERUs would be able to be reserved. Director Gerry Manfred makes a motion to approve these conditions and Director Bain seconds It. Motion carried.
- I. Rick informs the board about classes and the sanitary survey. He states that the tax rolls are up \$25,000 from last year. Director Bain makes a motion to purchase a skid steer from United Rental and Director Manfred seconds it. The Board of Directors of Model Irrigation District #18 met in Regular Session at the District Office, 1424 S Pierce Spokane, Washington on February 18, 2020. President Heaton calls the meeting to order.

### 2. MINUTES PRESENTED:

The Board reviewed and discussed the Minutes of the regular Board Meeting of January 29, 2020. Director Manfred made the motion to approve these minutes and Director Bain seconded the motion for the minutes to be approved as presented. The motion carried unanimously.

#### 3. NEW BUSINESS

- A. Aaron Dunham talks about the communications that have been exchanged back and forth between him and Mike Kinney's counsel (Elizabeth Tellessen) regarding Mr. Kinney's proposal to construct and donate a well to the District. Aaron also discusses that a well site will be donated before completion of the well. There is discussion regarding what the parcel of land may be worth and options for calculating that. There is discussion about whether or not once a value is decided, will a credit be given to Mr. Kinney against SDC's? Jesse Cowger suggests that we wait to see if the site is feasible for placing a well there before an amount is agreed upon. Also, the value of the property would need to be proven at that time.
- B. Elizabeth Tellessen discusses Mr. Kinney's proposal to reserve as many ERUs as Model is comfortable letting them reserve. There is discussion that Model Irrigation wants to not reserve all connections, so that there are additional connections for other anticipated development in the District. Ms. Tellessen also talks about their proposal that the payment for these ERUs / Connections be placed in an escrow account—since the Developer would later be entitled to a credit offset SDC's if the well is built, donated, and accepted. The target date of completion is 2023. Terms of the Developer's proposal are attached to these minutes.

to the district. The purpose of the executive session was announced, and the length of ten minutes was announced.

Ten minutes later at 9:24, President Heaton calls the regular session back to order. It was decided that Model would like to remove proposed condition number 8. A motion is proposed by director Goff to approve the proposed conditions without condition number 8. Director Bain seconds motion and motion passes. President Heaton asks Angie Sanchez to speak next. The question is raised whether Model should do another rate study to decide on future SDC charges. If a new rate is decided, D.R. Horton will pay the agreed upon amount of 15% of SDCs at the time of the permit. Jesse Cowger states that he can work with Angie to inform her on some of the projects that will need to be undertaken soon. They will draw up a proposal working together.

Superintendent Neal discusses classes, safety reports, overtime, and the issues with the SCADA computer "crashing". Director Goff suggests that we need to back up this computer with an external hard drive.

Director Bain motions to pay the expenditures of September 2023. Director Go ff seconds the motion. Motion passes.

Horton is aiming for a completion date of July 2024, before the end of November 2024 date, when credits towards SDCs will be reduced each month. She explains that the #8 force majeure clause was added for unforeseen catastrophes, such as Covid 19 epidemic. Jennifer informs the board that D.R. Horton wants this project completed in a timely manner for both Model and D.R. Horton. She also informs the board that they will have a check to Model by October end, for what is owed on their portion of SDCs to date.

Aaron says that he sees no ill intent from D.R. Horton in proposing condition #8, but it's up to Model's board of directors to decide.

The acceptable amounts allowed are set by federal standards. States can lower acceptability numbers under federal standards, but they can not exceed the set number. Jesse also explains the process of "blending" of waters. This is a process that takes water with passing numbers and blends it with water that have numbers too high to be acceptable are blended until all of it is passable.
